I. **GARMENT APPEARANCE**

Focus on the quality of work as seen when the garment is worn.

- A. Correct pressing
- B. Smooth seams
- C. Invisible hems
- D. Straight top stitching
- E. Plaids and designs matched
- F. Garment cut on the grain
- G. Details and closures lie smooth

II. **THE MODEL**

Focus on the model.

- A. Poised  
Model is self-confident and feels at ease
- B. Grooming  
Skin, hair and nails are clean, well cared for. Appropriate make-up and neat appearance.
- C. Modeling Skills and Presentation  
Model makes a good first impression, is self-assured, presents self with pride, a smile, and eye contact with the audience. Presents outfit to best advantage.

III. **OUTFIT ON THE MODEL**

Focus on both the model and the total look of the outfit.

- A. Total Look  
Outfit is a pleasing combination complement the model. The fabric texture, trims, findings, and color should be suitable for the garment design.
- B. Fit  
Appropriate amount of designer and standard ease to produce a good fit of neck, shoulder, sleeves, waist and side seams.
- C. Attractiveness  
Fabric emphasizes best illusion of the model and the design of garment. Color match personal color characteristics. Garment length and design in keeping with current fashion trends.
- D. Lines and Design  
Line creates an ideal look. Design appropriate for model.

IV. **SUITABILITY**

- A. Garment Appropriate  
Garment appropriate match for the category description.  
Appropriate for age of model.

3. What problems did you have?
4. What changes did you make in the pattern?
5. How long have you been participating in Fashion Revue?

7. What was the hardest part of making your outfit?
8. What new thing did you learn to do by making this outfit?
9. Where will you wear your outfit?
10. Did you learn to use any new sewing equipment making this outfit?
11. Will this outfit fit into your wardrobe?  
  
Especially if 4-H'er is wearing separates, will the separates work with other garments or produce new outfits?
12. For older members, how much did your outfit cost? Do you think you saved money by making it instead of buying it?
13. For older members, how will you care for your outfit?
14. Depending on the outfit, you may want to ask questions concerning:
  - Coordination of colors or fabrics
  - Choice of trims and notions
  - Choice of hem and seam finishes
  - Choice of accessories

I. Value of Money Spent

Focus on purchasing

Focus on the outfit

A. Fit

Figure is complemented. Figure problems de-emphasized. No strain or bagging of garments.

Alterations made if needed.

B. Quality for Money Invested

Garments of good quality.

Button holes on grain and sewed securely.

Fabric cut on grain.

Interfacing in collar and cuffs, etc.

Designs matched.

Seams flat and finished to prevent raveling.

Zipper securely and evenly stitched.

Seams of adequate width for the design.

C. Style

Provides for greater flexibility in wardrobe. Outfit suitable for more than one occasion and more than one season.

D. Care Requirements

Care cost is not excessive. Outfit durable, easy to care for and clean. All trim and workmanship durable with care required for the garments.

E. Cost

Price related to the quality and use of the item.

II. The Model

Focus on the model

A. Poised

Model is self-assured, presents self with pride, a smile, and contact with the audience.

B. Grooming

Skin, hair and nails are clean, well cared for. Make-up brings out the best features, yet produces a natural, fresh appearance.

C. Modeling skills and presentation

Model makes a good first impression, is self-assured, presents self with pride, a smile, and eye contact with the audience.

III. Outfit on the Model

Focus on both the model and the total look of the outfit.

A. Total look

Outfit is a pleasing combination complement the model. The fabric texture, trims, findings, and color should be suitable for the garment design.

B. Fit

Appropriate amount of designed and standard ease to produce a good fit of neck, shoulder, sleeves, waist and side seams.
